# ST. AUGUSTINE'S in-the-Woods Episcopal Church Minutes of Vestry Meeting February 15, 2023

**1. Call to Order:** This meeting in the Parish Hall was called to order by the Rev. Jennifer B. Cleveland at 3:05.

In attendance were Rev. Jenny Cleveland (Rector), Frank Shirbroun (Rector's Warden), Kathryn Beaumont (People's Warden), Gail Corell, Bernie Barker, Elaine Ludtke, Maureen Masterson, Brad Portin, Mark Anderson, Nancy Ruff (Treasurer), and Joan Johnson (Clerk). Stephen Schwarzmann joined in on Zoom.

**2. Reflections and Prayer:** Kathryn opened the meeting with a prayer and with a blessing from "To Bless the Space Between Us" by John O'Donohue.

## 4. Rector's Report:

The Rev. Jennifer B. Cleveland

- **A.** The Care Committee is functioning and is currently in discernment as to best practices.
- **B.** There will be a Welcome Committee training from 9:00 to 10:00 on February 26 for ushers, greeters, and Welcome Table staff. Gail suggested that perhaps the kitchen crew could be responsible for final locking up rather than the Welcome Table people.
  - **C.** Adult formation is a work in progress!
- **D.** Transition gatherings have begun and will continue until all have had an opportunity to participate. The plan is to have the same questions and topics for conversation at each gathering in order to have one common conversation.
- **E.** Conversations regarding safety at church and emergency preparedness are ongoing, with the goal of having protocols in place. Rev. Jenny handed out copies of reflections from Margaret Schultz and emphasized that it is important for people to know they are being listened to.

### 5. Treasurer's Report:

Treasurer Nancy Ruff

- **A.** Treasurer Nancy Ruff submitted her Financial Summary and Treasurer's Reports in advance of the meeting. We are at just over 8% of the year. As of the end of January total income and pledges were at 7% of the budgeted amount and total expenses at 8%.
- **B.** Brad asked about the organ repairs. Some pipes have bent and the organ makes a random strange sound. Henry Lebedenski has contacted someone to do the repairs. People have been storing things behind the organ, resulting in damage to the pipes. A sign will be posted letting people know not to use that space for storage!
  - **C.** The Audit Committee is scheduled to meet on February 28 at 3:00.

As soon as the last checks clear the operating fund at U.S. will be closed and all funds transferred to SaviBank.

- **A.** Kathryn attended a safety preparedness meeting and walk-about with Jenny and several church representatives. Mark (Buildings & Grounds) will organize and prioritize actions to be taken.
- **B.** The Lenten Jesus in the Movies series will be advertised on Drew's List and on posters in the community. Ash Wednesday services will also be on Drew's List.
- **C.** Future copies of the E-pistle will have a Warden's Column in order to help keep the congregation informed.
